

Terms and Conditions

The Subscriber hereby authorizes MTC to issue and deliver payment instructions to my / our Banker for collection against the above mentioned bank account. On condition that the sum of such payment instructions does not exceed the Subscriber's obligations as agreed to in the Subscriber Service Agreement, commencing on the commencement date of this Direct Debit Payment Instruction and continuing until this Authority and Direct Debit Payment Instruction is terminated by the Subscriber giving MTC written notice of no less than 30 ordinary days, and sent by prepaid registered post or delivered to the registered business address of MTC.

The Subscriber acknowledges that, due to payment becoming due, 30 days after invoice date and in view of the standard 30 day notice for contract termination this Direct Debit Payment Instruction will follow suit for the final invoice payment instruction, unless full and final account settlement is initiated by the customer prior to due date of the final invoice.

The payment instructions so authorized to be issued must be issued and delivered on a monthly basis.

The details of each payment instruction shall reflect on the Subscribers bank statement in the form of the abbreviated name "MTC081" followed by the Direct Debit Payment ID and the Account number, so as to enable both the Subscriber and MTC to identify the agreement. The said account number shall be communicated by way of the monthly MTC statement to the Subscriber before the issuing of any payment instruction.

In the event that the payment due date falls on a Sunday, or recognized public holiday in the Republic of Namibia, the payment day will automatically be the very next ordinary business day.

Furthermore, if there are insufficient funds in the Subscriber's bank account to meet the obligation, MTC is entitled to re-present the instruction for payment to my / our bank account for a period of up to 14 days (fourteen) and I / we herewith accept the associated charges applicable for an unsuccessful collection.

MTC shall provide the Subscriber with a monthly tax invoice and / or statement of account clearly reflecting the amount, due date and account number of the payment instruction to be deducted.

Due to some customary early payment of salaries in December, the Subscriber remains responsible to either personally initiate payment upon receipt of early salary or ensure sufficient funds remain in the bank account to guarantee this Direct Debit Payment Instruction be honoured.

The Subscriber acknowledges that all payment instructions issued by MTC shall be treated by the above-mentioned bank as if the instructions had been issued by the Subscriber personally.

Cancellation

The Subscriber agrees that although this Authority and Direct Debit Payment Instruction may be canceled by the Subscriber, such cancellation will not cancel the MTC Subscriber Service Agreement. The Subscriber shall not be entitled to any refund of amounts which MTC has collected while this Authority was in force, if such amounts were legally owed to MTC.

Assignment

The Subscriber acknowledges that this Authority and Direct Debit Payment Instruction may be ceded or assigned to a third party if the Subscriber Service Agreement is also ceded or assigned to that third party. MTC will inform the subscriber by registered post of the session. In the absence of such session or assignment of the Subscriber Service Agreement, this Authority and Direct Debit Payment Instruction cannot be assigned to any third party.

Declaration

The Subscriber hereby declares as follows:

- I/We have the necessary authority to sign this Authority & Direct Debit Payment Instruction.
- The information herein provided to you is true, correct and complete.
- I / We agree to be bound by signing this Authority & Direct Debit Payment Instruction.
- By signing this Authority & Direct Debit Payment Instruction, I / we agree that any previous Authority & Direct Debit Payment Instruction signed by me / us relating to Agreement Reference Number/ MTC acc. no.: _____ is hereby revoked.
