TERMS & CONDITIONS

- The VaxUpo81 enrolment application will allow customers to schedule an appointment for their Covid-19 vaccination at the vaccination site of their choice.
- The VaxUpo81 campaign can be accessed directly on vaxupo81.mtc.com.na, or by clicking on the VaxUpo81 logo on MyMTC App.
- Although the VaxUpo81 enrolment application will be open to anyone, only MTC customers will be eligible to receive the incentive bundle for their 1st vaccination dose.
- Only the first 130,000 MTC customers who receive their 1st vaccination dose by enrolment through the VaxUpo81 enrolment application will receive the bundle incentive. Upon termination of the campaign all customers will still be able to use the enrolment application.
- Upon enrolment, customers will receive an OTP to verify their enrolment and no duplicate enrolments will be possible.
- Upon successfully booking for a vaccination appointment, customers will receive an SMS confirmation of their booking and a reference number.
- All vaccinations will be validated, and qualifying customers will automatically receive their incentive bundle within 24 hours of being vaccinated.
- Once customers receive their first vaccine, they will receive the following:
 - Postpaid customers will receive a 3GB Data with a validity period of 60 days.
 - Prepaid customers will receive 1 free Aweh Super Bundle.
- The bundle incentive cannot be transferred or exchanged for any other MTC products or services.
- MTC shall be indemnified against any technical errors beyond its reasonable control.
- If due to any act or omission, this campaign does not run as planned, including problems with infection of computer virus, tampering, bugs, fraud, unauthorized intervention, technical failures and/or any causes beyond the control of MTC, which affect or corrupt the process, administration, security, integrity, fairness or proper conduct of this campaign, MTC reserves the right to disqualify any person who tampers with the application process, take any action that may be available and to cancel, modify, suspend or terminate the competition, subject to any regulations.
- By participating in this campaign, the customers are bound and subjected to all the Terms and Conditions of the campaign.
