

# MTC Motorsport Predictors Terms and Conditions

## CONDITION 1

1.1 The Directors, Permanent or Temporary Employees of MTC and their nuclear family members shall not be eligible to participate in this campaign.

1.2 Nuclear family shall mean the MTC Employee's children and spouse.

## CONDITION 2

2.1 The competition is open to all customers both prepaid and postpaid.

2.2 By participating and registering for this competition, customers bound themselves to these Terms and Conditions and further agree to adhere to these Terms and Conditions.

2.3 Before participating in this competition, MTC assumes customers have read and understood the terms and conditions thereof and that such participation is at the customer's discretion and risk.

2.4 MTC accepts no responsibility of any late, lost and/or misdirected entries including entries not received by MTC or delays in such entries due to network congestion, disruptions or for any reason whatsoever.

2.5 Should there be any inconsistencies between these Terms and Conditions and anything that refers to this campaign, these Terms and Conditions shall prevail.

2.6 MTC's decisions regarding the winners is final and as such MTC shall not enter into any correspondence regarding this competition's results or any other decision MTC may make in respect with the competition.

2.7 If more than one subscriber is tied for a prize, the subscriber to enter their predictions first will be deemed the winner. Thus, the order of the tied participants will be determined by who entered the competition first. E.g. if two participants are tied for 1st place, the participant that entered the competition first will win the 1st place prize and the participant that entered second will win the 2nd place prize and so on.

## CONDITION 3

3.2 In order to join the competition customers shall be charged a mobile subscription service charge of N\$3.00 per day, which offers the customers one entry to each competition and unlimited access to the relevant Motorsport predictors content for the duration of the customer's subscription.

3.3 The customer herewith authorizes MTC to recover the relevant amounts directly from the customer's available credit. The customer herewith confirms that they are able to engage in the aforementioned authorisation. Network charges may also apply.

3.4 Competition Day winners will receive their Airtime Vouchers within 48 hours after the competition ends. MTC will contact monthly cash winners after month-end via our contact centre.

3.5 The customer should be the registered owner of the Mobile Subscriber Integrated Services Digital Network-Number (MSISDN) (in short cellphone number) that was used to participate in the competition.

3.6 Any dispute of ownership of the MSISDN will result in that MSISDN being disqualified from the competition.

## CONDITION 4

4.1 This campaign will run from 01 July 2022 until 30 Nov 2023, both days included. All entries should be received by MTC prior to the closing date and time.

4.2 MTC shall run competition day and monthly competitions as per set schedule.

4.3 The competition shall run every qualifier and race day that real-world Formula 1 & Moto GP teams are competing at various circuits. Participants shall predict Motorsport qualifier and race day results of real teams from Formula 1 or Moto GP. A leaderboard tracks each team's performance in real-time. Winners win prizes based on their leaderboard position.

4.4. MTC airtime will be awarded to the winners with the correct predictions of the specific race day. The winners will receive the airtime voucher automatically on the specific MSISDN registered for the service, within 48 Hours after the races.
